The Examination Committee of the College met on 28<sup>th</sup> June 2024 (Friday) to pass the Supplementary Term End Examinations results conducted during June 2024 for the Under Graduate, Post Graduate and Post Graduate Diploma courses.

Dr T Santha, Principal, Dr. GRDCS and Chairman, Examination Committee welcomed the members of the Examination Committee and explained that the candidates having only one arrear paper from first to final semester are eligible for appearing Supplementary Term End Examinations to enable them to successfully complete his/her degree programme.

The Chairman informed that twenty five students were eligible for writing supplementary examinations and twenty four students attended the examinations. The examinations were conducted on 20<sup>th</sup> June 2024 and valuations were carried out. She placed the tabulated marks and mentioned the usual norms of moderation (awarding upto 2 marks per subject, subject to a total of not more than 5 marks in all subjects together) being followed for marginal cases of failed students.

- a) The Committee resolved that the existing moderation practice be followed to enable a pass in the subject/s concerned and that the results be passed accordingly.
- b) The Committee resolved that a student (Register Number: 22MBA037) who was not able to complete his degree due to shortage of 7 marks in the subject Elective: Taxation Management (22MBAW4).

The members suggested that the existing special moderation provision of upto ten marks may be given to enable qualifying for the degree. The committee accepted the suggestions and resolved that this provision of moderation be effected for Register Number: 22MBA03 only and the results passed accordingly.

The Committee resolved that the results be passed accordingly.

The Chairman stated that twenty three students are eligible for award of the Degree by appearing the Supplementary Term End Examinations and she also thanked the members for their support.
