#### Qualitative analysis of Criterion 1

The college is a private, self-financing, autonomous college and is affiliated to Bharathiar University. The college has 19 Undergraduate, 7 PG and 6 Ph. D Programs. The Academic Council and Boards of Studies of the college do necessary academic planning and curriculum development. The curriculum is updated based on the feedback received from stakeholders, alumni and industry. However, the broad structure of the curriculum is based on the UGC guidelines, the University and the State Council of Higher Education for UG and PG programmes. The PG Diploma in Entrepreneurship Development enables to develop the entrepreneurial skill of the students. To encourage entrepreneurship the college annually organizes several events which includes GRDMUN, Wolf of SCIB Street, Marketing Roadshow, Entrepreneurial symposium, Food Carnival etc. Along with the regular curriculum some skill-based and value-added courses are offered to the students along with their curriculum. A few such courses include- Association of Chartered Certified Accountants (ACCA), Business Analytics Course, Retail Management, Soft Skills, Digital Marketing etc. Some online courses through SWAYAM, NPTEL etc. are also offered to the students. For some of the Skill-based courses collaboration with external organizations are also seen which aims in improving the employability skill of the students. Students are encouraged to take up some live projects with some reputed business houses and media organizations. An in-house software called ASAS is in use for automated sitting arrangement of the students during exam. In the different events conducted in the college, extra-curricular events are also organized so as to groom the students' talents. Conferences and seminars, some of which of international level are also organized by the college. In connection to the community development program the institution has taken up events like GRD Swachhathon, Give What U Can, Tree plantation drives, visits to old age homes and orphanages etc. Some health-related programs and camps like anti-drug drive, healthy life style maintenance, Go Green initiatives, waste management are adopted by the college. Topics like environmental studies, women's rights, Gandhian thought, general awareness, people and culture of India are embedded in the curriculum. Themes on gender sensitivity, human values, professional ethics and environmental studies are also made a part of the curriculum either directly or through value added courses and is further emphasised through organizing of camps, workshops, industrial tours etc.

Feedback collected from the different stake holders like students, alumni, parents, teachers and employers are done.

Slow learners and advanced learners are identified in the college on the basis of performance of the students in H. Sc Exams, response of students towards classroom teaching and their performance in the Continuous Internal Assessment (CIA) tests. Special classes are arranged for slow learners and they are also put under constant monitoring under faculties as mentors. Confidence building talks, solving of previous years question papers, group study etc. are executed to improve the slow learners. The advanced learners are encouraged to enrol in MOOCs courses and to participate in debate, discussions, problem solving quiz programs, seminars, conferences etc.

Education is imparted to the students using the problem-solving methodology which includes- assignments and seminars. Several co-curricular activities like Sports and Games, Clubs, debates, group discussions are organized in the college. Projects and internships are an integral part of both UG and PG curriculum. The Institution has ICT-enabled classrooms to enhance teaching and learning. Mentor-Mentee practice is in place. Each student can discuss with his/her mentor the academic as well as non-academic problems. The mentors keep track of matters regarding the mentees' academic performance, progress in the completion of academic requirements, health problems and other grievances.

The college prepares the academic calendar at the beginning of every academic session. All the departments frame a plan of action for entire semester like- assignments, seminars, internship, skill-based training, social projects, FDP's, MDPs, industry interaction, projects, placement training and field visits based on the academic calendar. The exam schedule of the internal assessment and end-semester examination is also mentioned in the academic calendar. The Departments can schedule their activities in tune with the calendar.

Faculty members prepare lesson plans in advance for each of the subjects stating clearly the course content to be covered in each contact period.

The assessment of the students is conducted through– theory and practical exams, assignments, viva voce, activity-based assignments, research learning, MCQ Tests and seminars.

The evaluation process of the college for both the PG and UG programs are through CIA and End-semester examination. The examination process to a great extent is automated. Several exam related works like entry of marks, examinations scheduling, seating arrangement, attendance register, tabulation of marks, preparation of course-wise results etc. are automated. Supplementary Examinations are conducted within a month of the publication of results for the students who could not qualify the end semester examination.

The college uses a method similar to the Bloom's Taxonomy to compute the program outcome and course outcome. The college may conduct orientation program for the faculties to apprise them on outcome based education.

#### Qualitative analysis of Criterion 3

To develop a suitable environment for creation and transfer of knowledge and an ecosystem for research the institution has taken the following steps:

- 1. The management provide seed money to the departments and extends financial support to faculty members to attend national and international seminars, conferences and for journal publications.
- 2. The institute has signed MOU with some research institutes of the country to boost research activities

and collaboration. However, the outcome of such MOUs are yet to be realized.

3. Software training through Faculty Development Programs is also implemented.

In the institution, various activities are organized to promote students' holistic learning and to instil important values like Youth Parliament, Sustainable Development Goals, Model United Nation, Union Budget discussion, Formation of Startup etc.

The Business Lab helps the students to develop their entrepreneurial skills and enhance their skill as per the requirement of the recruiters. To gain knowledge and exposure of the students, the college invites renowned personalities from different fields of expertise, who share their experience with the students. To improve the aptitude and other employability of the students a separate set of trainers for placement training are involved.

The college has organized several awareness programs outside the organization on different government welfare schemes, gender equality, environmental issues, cleanliness, tree plantation etc. Some social service and health camps like eye checkup campaign, blood donation campaign, caring for animal welfare, educating on Good touch and Bad touch etc. Visit to old age / orphanage homes were also organized. SWACHHATHON, an environmental awareness programme under Swachh Bharat, is organized by the college every year so as to maintain and protect the environment. The college has an active National Service Scheme (NSS) cell that encourages students to get engaged in the community service and develop a service-oriented mind-set. They adopted three villages in the district.

Most of the class rooms of the college are equipped with ICT facilities like LCD projectors and Wi-Fi connection. The college has five seminar halls, guest house, placement halls, visitors room and board rooms in each block. The college has lift facility for staff and students but not in all the blocks. At different locations in the institute drinking water dispensers are installed. A few conference halls and an auditorium with proper acoustics is there. The campus is under CCTV surveillance. Ramps and wheel chairs are available for *divyanga* students. Department of Mass Communication has a theatre with all necessary facilities including a sitting capacity of 300 students. A Central Instrumentation Laboratory is there that has sophisticated equipment like Spectrophotometer, Low Freezer, PCR Machine etc. that can be used by students/researchers beyond the college. The college uses a Learning Management System (LMS) the academic process is managed through the LMS, Edu mange.

The library of the college is automated through an Integrated Library Management Systems (ILMS) through Edumanage and OPAC package. However, only one system has OPAC installed in it. All the subscribers of the college library are provided with a barcoded card. At the entry point the authenticity of the visitor are verified using a digital scanning facility. RFID technology is also in place. Online resources like INFLIBNET

N-LIST, NDLI, SAGE PUBLICATION, IEEE, S-Net Clarity Platform can be assessed in the library. The library has subscription to several newspapers and periodicals on different languages in addition to large number of text and reference books. However, some recent editions of the reference books shall be procured. The library of the college has a reading hall to accommodate about 80 readers. The library timings need to be enhanced beyond college hours for hostelers.

For sports and cultural activities, the college has an auditorium with a seating facility of around 1200 spectators and an indoor stadium. The college also has a has Throw ball court, Volleyball court, Basketball court, Gymnasium and Fitness Centre. The college has a play-ground of its own for outdoor sports. There are separate hostels (one each) for boys and girls. The hostels are well furnished and Wi-fi enabled. The hostels have modernized and clean kitchen. There are eight computer labs and about 800 computer systems. There is a Language Lab in the college, S-Clarity software installed in the systems therein. For maintenance of lifts, air conditioners, water purifiers, CCTV, Power back up and intercom facilities the college has agreement with different service providers. However, the cleanliness of classrooms, labs, campus are looked after by the regular housekeeping staff. The college has transport facility that takes care of mobility of the students, teaching and non-teaching members from nearby places to the college.

The college has an alumni association. There is indication of events and programs organized by the college are there who try to unite former students and use their expertise to inspire the current generation of the college. Alumni of the college shall be engaged in training and placement activities of the current students.

The institution provides financial help to students facing financial difficulties and approach the management. The college has a Centralised Placement and Training Cell to ensure that students are prepared for the competitive world following completion of the college education. Furthermore, students who demonstrate exceptional merit are granted fee waivers and merit scholarships from the institution's own funds. Students

The institution has a well-defined mission and vision. It has a decentralized and participatory management system.

The Governance of the college follows a hierarchical approach with the Governing Council at the apex. The Governing Council is framed as per the UGC guidelines- having a member from the affiliating university and a representative from the UGC. The Governing Council approves all the academic and administrative plans that are through the other bodies below the Governing Council.

Lower in the hierarchy is the Academic Council. The Principal is the Chairperson of the Council. The decisions of the Board of Studies regarding curriculum, evaluation and extra-curricular activities are discussed and approved by the Academic Council if deemed to be fit.

Below the Academic Council is the Vice Principal's office that supervise the teaching and the administrative staff of the college. Below the Vice Principals office is the Board of Studies. The Board of Studies frames the syllabus of the different programs. Reviews and update the contents of various courses from time to time.

In addition to these there is a Finance Committee that looks after the income and expenditure of the institution and frames the budget related to expenditure and allocation of funds under different heads. However, the minutes of the committee has to get the approval of the Governing Council before implementation.

In addition to all these several other specific purpose committees like the Student Grievance Redressal, Anti-Ragging, Internal Compliance, Curriculum Planning and Evaluation, Admission, Library, Purchase, Hostel, Sports, Extension Activities, Examination and Student Welfare are also there. The recruitment of faculties in the college is held as per the guidelines of the UGC, Tamil Nadu Government, and the affiliating university.

There are well documented leave rules for both teaching and non-teaching staff. Several types of leave like Casual Leave, Medical Leave, Earned Leave, Duty Leave are there. The teachers and the librarians also have vacations at the end of every semester.

The college provides group medi-claim insurance policy for all staff. Interest free loan facility for employees, advances for festivals and laptops to the faculties are also provided. Travel grants/registration fees are sanctioned to faculties to present research papers at national or international conferences in India and abroad.

Funds accumulated by the college beyond students' fees include letting its premise to conduct various sports meets and tournament at collegiate level, school level, competitive examination. The college has a study centre of IGNOU, New Delhi.

Operating of electric vehicle, solar based power generation and waste water recycling units are seen in the college. The expenditure of the college and the receipts are regularly audited both by the internal and external auditor.

The IQAC ensures that all academic tasks are executed properly. IQAC organizes workshop and looks after collaboration of the college with other reputed academic institutions (of India and beyond) to boost research output. IQAC collects feedback from different stakeholders which are further analysed by them, that are later used as policy recommendation.

The college has taken significant strides for the safety, security and instilling of confidence amongst the girl students. Several events are conducted by the college to ensure that the students are aware about the gender issues.

Some extension activities on different social issues, healthy practices and health awareness are conducted by the college through seminars, talks, walkathon etc. Girl Child Safety Day Pledge is organized in the institute in which students from all the classes took the pledge to provide safety to every girl child.

Plastics, metals, glass, cardboard wastes are segregated and sold to authorized vendors for their recycling. Paper wastes are sold to ITC for recycling purpose. Dustbins have been installed throughout the campus. E-wastes are disposed annually. The wastewater and sewage water treatment plant are there and the recycled water is then used for gardening. Vegetable and food waste are used for vermicomposting. The college is highly graded by Mahatma Gandhi National Council of Rural Education for environmental sustainability and waste management. Battery operated vehicles are used to remove garbage and electric equipment are used for cleaning the campus. The college has enough parking facility, it's a green and plastic free campus. Rain water harvesting is in place.

Most of the buildings are having lifts and ramps with steel railings for easy movement of the orthopedically especially abled students. Separate toilets and parking facility for specially abled persons are also there. The college celebrates days of national importance and several international days like the International Yoga Day, Ethnic day, Republic and Independence Day, Vivekananda Jayanti (National Youth Day), Teachers' day, National Voters' day etc. To apprise the newcomer students about the culture and working of the college, induction programme is conducted every year. Events like Youth Parliament, Social Service through NSS are organized in the college.

As best practices the college has documented its contribution towards social development. This includes interaction between students and local communities, knowledge sharing, identifying and solving local problems and undertaking of projects on local issues.

The distinctiveness of the college lies in the fact that the focus of the college is to prepare the students to face the real-life competition instead of concentrating solely on grades and curriculum completion. For that purpose, the college conducts various types of competitions and events like Creative Streaks, SCIB Bazaar, learning diary, film fest, hackathon etc.

#### Overall Analysis

#### **Strength:**

- The sanctioned teaching and non-teaching positions are filled up.
- The college has some MoU with some of the industries especially for some skill-based courses.
- To gain knowledge and exposure of the students, the college invites renowned personalities from

different fields of expertise, who share their experience with the students.

- The college has both 2(f) and 12B recognition of the UGC
- This is an autonomous college
- The hostels have smart kitchens and entry to hostels by non-residents are restricted by flak barriers.
- An in-house software called ASAS is in use for automated sitting arrangement of the students during exam.
- There are 8 computer labs and about 800 computer systems.
- The college has free transport facility that takes care of mobility of the students, teaching and non-teaching members from nearby places
- The college campus is green and clean.
- The college campus is Wi-Fi and several classes have LCD projection facility.
- The college has reasonably good facility for both indoor and outdoor sports.
- Waste management process is in place.
- There are Solar Energy Panels, Rain Water Harvesting Facility and sewage treatment plants in the college.
- The college has some value added and skill enhancement programs
- The college has a reasonably good basketball team with achievements at the state and national level.
- Some patents are registered and published by the faculty members of the college.

#### Weaknesses:

- There is a decreasing trend observed in the enrolment of students in the college in some of the courses over the assessment period.
- The sitting arrangements for teachers need improvement.
- No basic science programs are offered by the college.
- Government /Non-government Funded External Research Projects are not there.
- Research publication by the college faculties is more in UGC-CARE indexed journals but in the SCOPUS and Web of Science indexed journals are minimal.

#### **Opportunities:**

- The College can explore the possibility of starting of basic sciences courses
- The College can take necessary initiative to start the courses on Artificial Intelligence and Machine Learning, Data Science, etc.
- The College can establish an Employees' Cooperative Society which can provide financial assistance to the employees beyond the support provided by the college administration.
- The college can undergo some promotional activities to attract students coming from other states.
- The college should establish a NCC unit for both boys and girls.

#### **Challenges:**

- Improving the quality of research publication of the teachers.
- Resource mobilization for research from different funding agencies.
- Starting of more number of courses on basic sciences
- Improving of hostel facilities.
- Consultancy activities need to be initiated.

- Financial support from UGC and other Government funding agencies may also be explored.

- The college shall establish a health centre with Medical Officer and supporting staff.
- The in-house research journal shall be displayed in a more prominent way in the college website
